

## Set Aside Clinic

If you have an Arizona conviction on your criminal record, you may qualify to set aside your conviction and restore your civil rights.

Community Legal Services is able to provide direct representation to qualifying individuals.

You do not need to pre-qualify in order to attend the clinic. All are welcome at the clinic; however, you must qualify in order to obtain direct services from an advocate. Eligibility is determined in part by income level and immigration status.

**What you need to bring to the clinic:**

### Information about:

- ⇒ Your Identification
- ⇒ Case Number (s)
- ⇒ Date of arrest / Arresting Agency
- ⇒ Date of the plea and what you plead guilty to
- ⇒ Date of discharge from probation

### Document showing:

- ⇒ Absolute discharge letter from ADOC

### Please note:

Your felony record (s) cannot be expunged, sealed or deleted.

**Not all convictions can be set aside.** If you have a sexually motivated crime and/or your crime requires registration you will not qualify for a set aside.
