

## arizona coalition against domestic violence Consequences of Avoiding Court Service respond to have your voice heard in court

Do you think that someone might be trying to serve you with court papers about divorce, legal decision-making (custody), or parenting time? Even if the person trying to serve you can't find you—if you're out of state or in shelter—the court process can go on without you, without your having an opportunity to tell a judge your side. You can even be served "by publication" (a notice in the newspaper).

You can explain to the court what you want by filing a response. If someone is trying to serve you and you don't respond, there can be negative consequences.

You have 20 days from the date of service to respond to court papers. If you do not respond within 20 days of service, the person trying to serve you can file for a default judgment. A default judgment allows the person who is trying to serve you to get what he or she asked for, because the judge never had an opportunity to hear your side. The person trying to serve you can get a default judgment 10 days after requesting it. If you don't respond, a judge will make decisions about your family without input from you.

To see if a court process about you or your family has begun, contact the Clerk of Court in the county where you or your ex-partner lives, or where a court may have previously issued an order.\* It is important to check with the Clerk every few days to make sure you don't miss a filing deadline or a court date. There is a delay from when something is filed to when it is available online, so even if you can look up your case online, it is important to call the Clerk. When you call the Clerk you can ask: "Is there anything that has been filed in Family Court that I need to respond to?"
