LEFT UNRESOLVED, THESE CIVIL ISSUES WOULD RESULT IN HOMELESSNESS, CONTINUED ABUSE AND DOMESTIC VIOLENCE, LOSS OF LIMITED INCOME DUE TO CONSUMER FRAUD AND ILLEGAL EMPLOYMENT PRACTICES, LACK OF HEALTH CARE AND THE RIGHT TO PUBLIC SCHOOL EDUCATION FOR CHILDREN WITH DISABILITIES WOULD HAVE ESCALATED. CLS ALSO SHARED INFORMATION AND RESOURCES WITH APPROXIMATELY 25,000 PERSONS THROUGH COMMUNITY OUTREACH AND EDUCATION OPPORTUNITIES THROUGHOUT OUR FIVE COUNTY SERVICE AREA.
